This position will support the Centre with operational requirements including maintaining ECE ratio and meeting the requirements of the Early Learning and Child Care Act & Regulations. The position is a term from 27 Mary 2024 to 31 August 2023. 40 hours work week, shifts may vary from day to day.

### Family Support

- Ensure confidentiality in working with families and clients of the Military Family Resource Centre
- Effective communication with the Director, Assistant Director and other ECE's regarding program, parent concerns and all matters pertaining to the children enrolled
- Daily communication with ECE's; keeping informed of all pertinent information regarding children

### **Program Delivery**

- Provide classroom and ratio coverage for ECE leave
- Provide extra classroom support as identified by the Director/Assistant Director, i.e. Field trips
- Provide a safe, nurturing and stimulating learning environment to enhance development in all areas, while providing for the health and social well-being of the children
- Work collaboratively with other ECE's, students and volunteers in a team environment
- Responsible for program and curriculum implementation in cooperation with other ECE's, in accordance with developmentally appropriate practice, which will allow children to make choices
- Responsible for the active supervision and interaction of children enrolled
- Use of appropriate positive behavior guidance techniques
- Establish and maintain effective communication with children, staff, parents, Inclusion Coordinator, Assistant Director, and the Director
- Responsible to maintain a clean and healthy classroom environment including toys and equipment as per Early Learning and Child Care Act & Regulations
- Responsible for implementation of the Centre's inclusion philosophy; working in cooperation with Inclusion Coordinator as required to support children
- Must have awareness of and be able to implement Centre policies and parent policies in accordance with the Early Learning and Child Care Act & Regulations
- Must adhere to all Centre and ECE policies in accordance with the Handbooks; and
- Willingness to work with children of all ages
